Why is it that the sculpture **Survival of the Fattest** resonates, especially now, with people all around the world. Why is it that someone from the Dalit class in India sees the same thing as someone from Brazil? Because the face of global politics today looks the same no matter where you're standing. President Lyndon B. Johnson once said, "If you can convince the lowest white man he's better than the best colored man, he won't notice you're picking his pocket. Hell, give him somebody to look down on, and he'll empty his pockets for you." The past tends to repeat itself because people as a rule think they're getting smarter, they take solutions from the past, to the same problems in the present for granted, because they think we were already supposed to have learned that lesson.

I don't think the comparison to the rise of Nazism in the 1930s to today's social climate is an unreasonable one. The sanctions imposed by the Treaty of Versailles, describing the reparations an already devastated Germany would have to pay back for their part in the war destroyed their chances of rebuilding the economy. And so the German people suffered, money was useless and whatever money they had went to the allies. Hitler saw an opportunity to revive Germany by playing on his desperate public's need to



find someone to blame for their ruin. The Jews seemed okay in the aftermath of the war because in the Torah, unlike the Bible, lending money on principal is not unholy. So they were able to maintain their small businesses on interest alone, allowing for survival in a stagnant market. Instead of underlining the points in their smaller working economies to the people, Hitler demonized them as some evil cabal feeding off their misery, laughing while the rest went hungry. He used this wave to persecute the Jews, and the costs that came with it did revitalize Germany after seizing their assets and creating a new economy complete with a free workforce labouring towards their own encampment. His goal for restoration worked, and although the average German was raised from poverty the whole thing came crashing down after his real goal for

world domination failed. The curtain lifted, and the German people were sent back 15 years minus the cost of a few million lives.

It's this kind of heartstrings pandering that perpetuates the same problems today; it's not a question of man vs man, it's who's behind the megaphone telling them why the other side is responsible for their poverty. This model filtered through the arrogance of unhappy people and their unwillingness to believe that things are more complicated than they seem allows these demagogues to play partisan politics; they take advantage of society's general ignorance when it comes to the way the world works so the people keep looking at themselves for someone to blame, electing those who won't change anything, and pushing them further and further away from a system they're entitled to. The people who elected Trump on this platform, mostly middle Americans whose only contact with anyone not white is almost non-existent, were so swept up by the promise of a "better America" that they'd rather spend their tax dollars on a wall than reinvest in education and public programs for themselves, because that would stink of socialism. They support a travel ban from Middle Eastern countries under a temporary guise of increased security to keep supposed terrorists out, while the only people being kept out are naturalized citizens, doctors, PHD students, well integrated people America needs to better itself. Out of the 6 countries banned under the order, the two countries whose nationals account for almost all of the terrorism committed on American soil, Pakistan and Saudi Arabia, aren't on the list. While the far right preys on voter ignorance to stay rich and keep the rest where they are, all the left does is maintain the status quo. While people like Donald Trump's and Theresa May's policies look regressive to those on the left who consider themselves informed, under Obama no bankers responsible for the 2008 financial crisis in America were prosecuted for bundling bad loans and defrauding the American public because of the negative impact they thought it would have on the economy; instead they were bailed out by taxpayer money only to raise interests on the same public to pay the government back at a profit.

This is why Populism is more important today now more than ever, because we need to realize that a choice between lesser evils isn't good enough anymore.
