Since then, numerous letters, calls and personal visits has led to two replies and the notion that the Universities legal representatives do not have any instructions from HKU in respect of our proposal to inspect and remove the Pillar.

She is told they "have no authority to let her check the Pillar". She hand-delivers a request letter to see the statue to the Kadoorie Center.
17 January 2023	Calls	To HKU Kadoorie Center, Estate Office, and also to the Hotline.
18 January 2023	Visit + letter	Ms. Loretta Lau visit and hand-deliver request letters to both the HKU Estate office and to the President's Office.
7 February 2023	Letter	Ms. Loretta Lau receive an email from the President's Office of The University of Hong Kong, writing "Thank you for your message. The matter is receiving attention." - Since then nothing has happened.
